

○2024 Admission Fee Exemption and Admission Fee Deferred Payment

1. Eligibility

For those who fall under any of the following are eligible. For Privately-Financed International Students, the situation in Japan is applicable, and the situation in their home country does not qualify for application.

- 1) Students who have difficulty in paying their Admission Fee for financial reasons (excluding loan repayment or other debt), and who are moreover recognized as excellent academic achievers.
- 2) Students who face extreme difficulty in paying their Admission Fee within one year before enrollment because their household supporter passed away or students who themselves and/or their household supporter have suffered from a natural disaster such as a storm or flood.
- 3) The main household supporter or students have been affected by the following catastrophic disaster.
The target catastrophic disasters: Heavy rain in July 2020 · Noto Peninsula Earthquake in 2024
- 4) Cases equivalent to the above, and approved by the President.

*Please note that the Admission Fee paid before the application for Admission Fee Exemption/Deferred Payment and before notification of the result of the application is non-refundable. (Excluding admission fee for G30 program students.)

2. Amount of Admission Fee Exemption

For those who are approved exemption, they will be exempted from paying the full or half amount of Admission Fee.

However for Graduate Students have been only approved half exemption in recent years.

Applicants who are approved a half exemption, or not approved, must be transferred the outstanding Admission Fee within 20 days including the date of notification.

3. Admission Fee Deferred Payment

The term of Deferred Payment is until the end of February. It does not mean an exemption. The Admission Fee must be transferred without fail by the end of February.

4. Admission Fee Exemption and Deferred Payment

It is possible to simultaneously apply for both an exemption and deferred payment by submitting a complete set of application forms.

In the case of a combined application for exemption and deferred payment, if a half exemption is approved or if the application for exemption is disapproved, payment of the admission fee can still be deferred until the end of February, provided that the application for deferred payment is accepted.

5. Submitted Documents

6. Acceptance of Documents for Submission

Applications will be accepted during the enrollment process from (Wed), Sep. 4 to (Tue), Sep. 17.

7. Flow after Admission

After enrollment, please complete the procedure for Tuition Fee Exemption application through the "Tuition Fee Exemption Student Application System". (Hereinafter the "Exemption system") If you submit required documents displayed on the screen, the procedure will be completed. This also allows students to apply for tuition fee waiver.

If the application for Admission Fee Exemption has been completed but the application for Tuition Fee Exemption has not been completed, the result of both applications will be "disapproved".

8. Notification of Results

Notification of result will be made around early December in the " Messages For You " section of the "Educational Affairs system", which will become available after enrollment.

9. Other

Once an application for exemption or deferred payment has been received, payment of the Admission Fee is effectively deferred until the results of the application are announced.

~~Applicants who are approved a half exemption, or not approved, must be transferred the outstanding Admission Fee within 20 days including the date of notification. Failure to pay the Admission Fee will remove from the register.~~

However, if these students also applied for deferred payment and received approval, payment is effectively deferred until the end of February. ~~(If no payment is received by the end of February, the student will be removed from the register.)~~

○2024 Tuition Fee Exemption For Fall Semester

For those who are approved exemption, they will be exempted from paying the full or half amount of Tuition Fee. If you apply for Tuition Fee Exemption in the Fall semester, you will only receive it for the Fall semester. If you would like to apply for Tuition Fee Exemption for the following year, please apply again in the Spring semester. Application information for the Spring semester AY2025 will be available in early February.

1 0. Eligibility

For those who fall under any of the following are eligible. For Privately-Financed International Students, the situation in Japan is applicable, and the situation in their home country does not qualify for application.

- 1) Students who face difficulty in paying their Tuition Fee due to economic reasons (excluding loan repayment or other debt) and are recognized as having excellent academic achievements.
- 2) Students who face extreme difficulty in paying their tuition fee within one year before enrollment because their household supporter passed away or students who themselves and/or their household supporter have suffered from a natural disaster such as a storm or flood.
- 3) The main household supporter or students have been affected by the following catastrophic disaster.
The target catastrophic disasters: Heavy rain in July 2020 · Noto Peninsula Earthquake in 2024
- 4) Cases equivalent to the above, and approved by the President.

1 1. Using the Tuition Fee Exemption Student Application System (Hereinafter the "Exemption system")

The application process for Tuition Fee Exemption is completed through the "Exemption System" and is completed by submitting the required documents displayed in the system.

Please complete the procedures during the system availability period and submit the documents by the deadline described in "13. Acceptance of Submitted Documents".

Exemption System Application Period : (Sat), October 12th – (Fri), October 25th, 2024 noon (JST)

* Applications will not be accepted after the usage period.

* Exemption system is accessible through the NU PORTAL which will become available after enrollment.

* After entering all item, required documents are displayed. Because documents issued by government offices are required, please apply as soon as possible regardless of the application period.

* To log in to the Portal Site and the Exemption System, you will need to enter your THERS account and THERS account password. Please don't forget to change your THERS account password and complete the "Information Security Training".

After (Sat), October 12th, please log in to the Exemption System.

If you enter from a Nagoya University undergraduate or graduate school, your THERS account will remain unchanged.

1 2. Submitted Documents

Please check the documents displayed when you complete the exemption system entry and submit the necessary documents.

Please print out the various Sheets from the "Exemption Application Print" page of the system.

Please print out the various Forms from the NU PORTAL > Dashboard > Administration Procedure > Student Counseling > Submitted Documents.

1 3. Acceptance of Submitted Documents

Documents can be submitted at Student Support Division counter or send by Post mail (Acceptance-recorded mail or Letter Pack Light, etc., which will keep a record.) by the deadline. Student Support Division is open from 9:00a.m to 5:00p.m on weekdays.

【Deadline】 (Fri), October 25th, 2024 【MUST ARRIVE】

1 4. Notification of Results

Notification of result will be made in the "Messages For You" section of the "Educational Affairs system" which will become available after enrollment. (scheduled for mid-December)

1 5. Other

Once an application for exemption has been received, payment of the Tuition Fee is effectively deferred until the results of the application are announced. For those who are not exempted in full, the Tuition Fee will be deducted from your registered tuition bank account on the date to be announced in the result notification.
